- 4. Old Business

Motion was made by Blake Schmidt to remove swine from the prohibited animals list. No second motion, motion failed.

- New Business
- a) Discuss and possibly take action on deed restriction violation by Blake
 Schmidt for violation of restrictions under Article IV Section 4.01: Animals 7 (a) Prohibited
 Animals which states "Prohibited animals include but are not limited to: donkeys, mules, swine, and all manner of fowl."

32202 Grove Park Dr. Adams, Dean & Lisa - the antique vehicle and parts have been in their front yard for 5-7 years with no complaints until recently. These antiques have been considered "yard art" by many neighbors and there is no further action required.
